Search for a property by typing in the address in the search bar or Tax Map Key (TMK) number in the TMK Search window.



Click on the structure or parcel of interest. A "Parcel Quick View" window will open.

Click "parcel details" to display the property details, including the dam evacuation zone assessment.

Click on "print report" for a copy of the Flood Hazard Assessment Report, including dam evacuation assessment.
